

05 ANATOMY OF LIMITLIS®

Patient/Client Portal

LimitLIS[®] features secure portals for your own clients and/or individual patients, enabling those parties to perform various actions in LimitLIS[®] via permission-controlled access. Individual patients with system access will login and see only their own test results. Your clients with login access can create orders and submit information directly, minimizing time wasted on manual data entry and minimizing errors. In addition, your clients may view their test results immediately after your lab approves them for release. The time it takes to transfer information, as well as the risk of rework and even loss of customers due to data inaccuracy, is reduced with LimitLIS[®].

Laboratory Dashboard

LimitLIS[®] laboratory management dashboard features easily understood, key analytical data displays and charts to help you manage your laboratory business. Staff testing volumes, laboratory turnaround time performance (TAT), sample volumes, and EMR/billing report submission statuses are examples of what your lab may select for its home screen dashboard content in LimitLIS[®]. With these tools, laboratory managers can gain better insight and make decisions to improve the performance of their lab while identifying opportunities to reduce expenses.





Paperless E-Requisitions

LimitLIS[®] helps your organization eliminate waste and transcription errors through its paperless e-requisition feature. Your clients submit requisitions securely though the LimitLIS[®] Client Portal directly to your lab, entering data such as patient information, billing details, ordered tests, and point-of-care test results. LimitLIS[®] can be configured to hide unnecessary data types and workflows to make its user interface fit your lab and clients.



Sample Tracking & Storage

Receive samples in the laboratory; assign sample accession numbers; design and print linear, 2D, and RFID barcode labels; and track samples through your entire testing process with LimitLIS®. Once testing is completed, store samples in perpetuity or for a defined timeframe using our Storage Module. With LimitLIS®, lab staff will always know where their samples are at any given moment. LimitLIS® additionally posts a system alert highlighting samples that are past their expiration date, allowing you to review and discard samples kept past their storage deadline. Never struggle with a cluttered freezer again!



Test Results Acquisition

LimitLIS[®] supports many types of data entry. With unidirectional and bidirectional integration support, analyzers receive test orders from and report test results back to LimitLIS[®] automatically. If the auto-verification option is enabled, normal results are automatically finalized, requiring analysts to simply monitor for exceptions or abnormal results. LimitLIS[®] can additionally process instrument result file uploads or test results can be entered manually by your staff.





Integration

LimitLIS[®] supports direct unidirectional and bidirectional integration with a variety of EHR and billing providers through the HL7 Messaging Standard. The HL7 interface designer ensures that LimitLIS[®] will be able to integrate with your systems. Using bidirectional EHR integration, LimitLIS[®] receives test orders from your EHR, creates requisitions, and returns results back to the physician and/or EHR as soon as they are released. Integration with billing providers ensures that the patient or their insurance company are automatically billed for completed tests, improving cash flow.



Quality Control & LJ Charts

LimitLIS[®] Quality Control Module tracks control sample lots, lot expiration dates, and equipment used in each quality control run with support for both qualitative and quantitative QC result tracking. QC runs can be re-run when out of range and test results that exceed configured QC ranges are automatically flagged for verification. Lab Mangers can quickly generate Levey-Jennings charts by specifying a timeframe for the report and filtering by analyte or instrument.

LimitLIS[®] is a cloud-based solution that will grow with your lab and can be accessed anywhere, on any internet-enabled device, by your staff and clients.
